Daycare / Boarding Agreement

Ruff Daze Daycare and Boarding ("RDDDB") agrees to exercise due diligence and reasonable care, and to keep the premises sanitary and properly enclosed. All pets are handled or cared for by RDDDB staff without liability on RDDDB's part for loss or damage from disease, theft, fire, death, escape, injury or harm to persons, other pet(s) or property by said pet(s), or from other unavoidable causes, due diligence and care having been exercised.

OWNER UNDERSTANDS THE RISKS INVOLVED IN "FREE PLAY" AT DAYCARE AND ACCEPTS THAT SOME INJURIES MAY RESULT FROM SUCH INTERACTIONS. The RDDDB staff, in its sole discretion, reserves the right to (a) treat such injuries onsite, or (b) have the pet seen by a veterinarian if it is deemed that such injury requires veterinary care. Owner agrees to pay any veterinarian fees pertaining to any injuries.

Owner agrees to pay the rate for daycare/boarding in effect on the date the pet is checked into RDDDB. Prices are subject to change at any time, without notice. No pet will be released until all charges are paid in full. Late cancellation fees may also be applied for reservations cancelled after 8:00 am on the day prior to the scheduled reservation. RDDDB shall have, and is hereby granted, a lien on the pet for any and all unpaid charges resulting from daycare / boarding services at RDDDB. Owner shall remain liable for complete daycare/boarding bill as well as other charges incurred in the care and maintenance of said listed on this contract. The Owner further agrees to be solely responsible for any and all acts or behavior of said pet while in the care of RDDDB. The Owner of the pet agrees to pay reasonable attorney fees incurred by RDDDB in the collections of any daycare/boarding services or other charges incurred by the Owner of the pet.

The pet must be current on the following vaccinations: Distemper, Hepatitis, Parvo, Bordetella and Rabies. Valid proof of vaccinations must be presented before pets can be dropped off for daycare/boarding. Further, Owner agrees to remain current on all vaccinations and to provide proof to RDDDB of maintenance. Owner also agrees to keep the pet on a heartworm preventative as well as free from fleas and ticks. Pets arriving with fleas/ticks will be bathed at the Owner's expense. RDDDB suggests that all pets be spayed and/ or neutered, WE DO NOT ACCEPT ANY FEMALE IN HEAT. If your pet is in heat or comes into heat in our care it will be an additional \$40.00 and your pet will need to be released to another facility or to a person designated for pick up by the owner. Owner accepts that RDDDB is not responsible if the dog becomes pregnant. Owner agrees to provide food for the pet for the duration of the stay. Owner agrees to pay \$1.00 per day for 40 lbs or less and \$2.00 a day for 40lbs or greater if food is not provided by the owner.

RDDDB reserves the right to refuse any pet.

RDDDB is not responsible for damage to any personal items i.e. bedding, blankets, left for your pet while in our care.

Owner agrees that the pet will be picked up from daycare by Owner or a pre-approved Owner's agent by 6:00 pm, unless prior arrangements have been made. Owner also understands that check-out time for boarding pets is 5:30 pm. Owner agrees that if pet is not picked up by 6:00 pm the pet will then become a boarder and will be charged for the additional boarding fee. If the pet is not picked up after 2 days, and further arrangements have not been made, the pet will be turned over to Douglas County Animal Shelter.

Owner agrees that their pet may be video taped, photographed and recorded RDDDB shall be the exclusive owner of the results and all proceeds of such tapings, photography and recordings with the rights and unlimited number of times in perpetuity, to copyright, to use and to license to others in any manner. The Owner further agrees that the pet may be used in any and all media and in the promotion, advertising, sale, publicizing and exploitation of RDDDB.
